

## PANTHERS BATHURST | Terms & Conditions: **Briefcase Bonanza**

### Conditions of Entry

1. The promotion is conducted by the Panthers Bathurst under Penrith Rugby League Club Limited (ABN 57 000 578 398) 132 Piper Street Bathurst NSW 2795. Telephone number (02) 6330 0600.
1. The promotion period operates from **Sunday 11 February 2018 through to Saturday 7 April**
2. Promotion is open to current financial members, life members and permanent members and excludes Directors, Management, Staff, contractors and their employees of the Club and related companies.
3. The promotion comprises of **(i) Daily Draws (ii) Saturday Draws (iii) Major Draw**
4. Draws are held at the Panthers Bathurst premises (132 Piper Street Bathurst NSW 2795) and communicated from Thursday 1 February 2018.
5. It is the responsibility of members to be in an area of the Panthers Bathurst premises where they can hear draw announcements.
6. A member must personally present their current financial membership card to the promotion host within four (4) minutes of the announcement to claim any prize.

### Entry to Draws

1. Entry is gained by a member making a purchase at the Players bar, Sports bar, Raffle station, or Panthers Bistro on the day of each draw.
2. Members must present their club membership card to the clerk at the time of purchase to be swiped through the POS system. On doing this, the till will issue an entry ticket.
3. Entry tickets are to be placed into the marketed entry barrel.
4. It is the responsibility of the member to have their entry ticket into the correct barrel before the draws.
5. In the event of till malfunction, a receipt with the member's name and staff signature will be issued as a barrel entry.
6. Only one standard entry ticket will be generated per purchase location (ei. the Players bar, Sports bar, Raffle station, or Panthers Bistro) per member per day.
7. **Extra entry tickets** are gained for every \$10 spent by a member at the Players bar, Sports bar, Raffle station, or Panthers Bistro on the day of each draw.

### (i) Daily Draws

1. Each **Sunday, Monday, Tuesday and Wednesday** of the promotional period, Daily Draws will take place at the following times:

**2pm, 2.30pm, 3pm, 3.30pm, 4pm**

2. 1 (one) winner will be drawn from that day's tickets and announced via the Club's PA system.
3. Winners must be in the club to participate in the promotion.
4. The winner will have 4 minutes to personally present their current financial membership card to the promotion host, and if not present, a re-draw will take place until a winner is found.
5. Each winner will pick 1 (one) of the **5 (five) briefcases** in the order of which they were drawn out.
6. The host will open the chosen case to reveal the prize amount
7. Each briefcase will hold a random prize of the following amounts:

**1 x \$300 2 x \$200 2 x \$150 (\$1,000 in total each Daily Draw)**

### (ii) Saturday Draws

1. Each Saturday of the promotional period (excluding the final Saturday), Saturday Draws will take place at the following times:

**7pm, 7.30pm, 8pm, 8.30pm, 9pm**

2. 1 (one) winner will be drawn from that day's tickets and announced via the Club's PA system.
3. Winners must be in the club to participate in the promotion.
4. The winner will have 4 minutes to personally present their current financial membership card to the promotion host, and if not present, a re-draw will take place until a winner is found.
5. Each winner will pick 1 (one) of the **5 (five) briefcases** in the order of which they were drawn out.
6. The host will open the chosen case to reveal the prize amount
7. Each briefcase will hold a random prize of the following amounts:

**1 x \$1,500 2 x \$750 2 x \$250 (\$3,500 in total each Saturday Draw)**

### (iii) Major Draw

1. On the final Saturday of the promotional period (**Saturday 7 April 2018**) at 8.30pm a **Major Draw** will take place.
2. 10 (ten) winners will be drawn from that week's tickets and announced via the Club's PA system.
3. Winners must be in the club to participate in the promotion.
4. The winner will have 4 minutes to personally present their current financial membership card to the promotion host, and if not present, a re-draw will take place until a winner is found.
5. Each of the 10 (ten) winners will pick 1 (one) of the **10 (ten) briefcases** in the order of which they were drawn out.
6. Each briefcase will hold a random prize of the following amounts:

**1 x Toyota Rav 4 (\$36,000), 1 x \$1,500 2 x \$750, 2 x \$500 4 x \$250  
(\$41,000 worth of prizes in total)**

### General

1. **Total prize value for the period of the promotion is \$97,500 (\$61,500 cash prizes and Toyota Rav 4 valued at \$36,000).**
2. Payments up to \$2,000 will be made in cash and the balance of the prize will be in the form of a crossed cheque that will be issued within five (5) working days.
3. An independent scrutineer will be present for all draws with a single prize valued at over \$10,000.
4. The Club collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this information. Entrants should direct any request to access, update or correct information to the Club. All entries become the property of the Club.
5. If there is a dispute as to the identity of an entrant, the Club reserves the right, in its sole discretion, to determine the identity of the entrant.
6. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Club, the Club reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
7. Except for any liability that cannot be excluded by law, the Club (including its officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Club's control); (b) any theft, unauthorized access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Club) due to any reason beyond the reasonable control of the Club; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or entrant; or (f) use of a prize.
8. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
9. Entry is open to New South Wales residents aged 18 years or over who are fully financial members of the Club including proposed members and excluding barred/suspended, Directors, management and employees of the Club and its related companies and its marketing agencies are not eligible to participate in the Promotion and shall be ineligible for any prize covered herein. Entrants acknowledge that the Club is not liable for reimbursement of any prizes otherwise payable to eligible entrants who are in violation of this provision.

The Club reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age, membership status and place of residence) and to disqualify any entrant whose entry is not in accordance with these Terms and Conditions or who tampers with the entry process. Errors and omissions may be accepted at the Club's discretion. Failure by the Club to enforce any of its rights at any stage does not constitute a waiver of those rights.
