

## **\$430,000 Membership Giveaway Promotion Terms & Conditions**

Promotion Name: \$430,000 Membership Giveaway

Start Date: Tuesday 1 September 2020 at 9AM

Promotion End Date: Saturday 31 October 2020 at 11.59PM

### **How to Enter**

1. Promotion is open to renewing members, new members and life members of Penrith Rugby League Club Limited.
2. One scratch card will be given to life members and each member over the age of 18 years who renew their membership for 2020/21 or join as a new member.
3. The scratch card will be given to the member upon collection of their new membership card from reception during the promotional period only.
4. The member must scratch the scratch and win panel to reveal their prize. You must match three (3) symbols to win that corresponding prize.

### **Prizes**

5. A total of 55,020 total scratch cards will be produced that will contain a total of \$430,000 (RRP) worth of prizes including
  - 20 x \$500 instant win cash prizes
  - 2,000 x \$20 instant win cash prizes
  - 4,000 x \$15 food and drink vouchers
  - 15,000 x \$10 food and drink vouchers
  - 34,000 x \$5 food and drink vouchers
6. Instant win cash prizes must be collected before they expire at 11.59pm on 31/10/2020.
7. Food and drink vouchers are redeemable at Panthers owned restaurants and bars the month following collection of your scratch card. For example, if you collect your new members card and scratch card during September 2020 you will be able to redeem your food and drink voucher during October 2020. If you collect your new members card and scratch card during October 2020 you will be able to redeem your food and drink voucher during November 2020. The redemption period will be clearly marked on the front of the scratch card. The food and drink voucher will expire following this marked redemption month
8. Food and drink vouchers must be used in one transaction and no change will be given for any unused portion of the voucher.
9. The food and drink voucher discount will be applied to the Member's price of the menu items.
10. Food and drink voucher prizes are not redeemable for cash.

### **General**

13. The scratch card will be surrendered by the Panthers staff member when you redeem your cash prize or food and drink voucher.
