Promotion Terms & Conditions

Promotion Name: Holiday PAYDAY

Start Date: Monday 1 September 2026

End Date: Sunday 25 October 2026

Draws: At 5:30pm Sunday 27th September & Sunday 25th October. The Promotions Host will draw 4 names from the barrel on each draw night.

Draws night will be as follows:

Sunday 27th September- 1x Cruise (Value of \$3,000), 1x \$1,000 cash, 2x \$500 cash

Sunday 25th October- 1x Cruise (Value of \$3,000), 1x \$1,000 cash, 2x \$500 cash

How to Enter

1. Promotion is open to renewing members, new members, multi-year members, permanent and life members of Penrith Rugby League Club Limited from 2026 onwards.
2. Members will receive 1 ticket from the kiosk every Sunday after they have renewed for the chance to win 1 of 2 Royal Caribbean Cruises and a share of \$4,000 in cash.
3. Members who join or renew their membership on the day of the draw will receive a manual entry ticket from reception instead of an entry via the kiosks.
4. Membership status must be Full/Financial in order to gain entry into the promotion, with membership valid for 2027 year and beyond.
5. Members who are in Renewal or Lapsed status are not eligible for the promotion.
6. Eligible members can swipe their card at the Swipe Kiosks between 9am and 5:25pm on Sundays to get their ticket into the draw.
7. Up to a total of 8 tickets can be claimed per member (1 every Sunday during the promotion period)
8. Members must place their ticket in the specially marked barrel at Panthers Bathurst on Sunday 27th Sept and Sunday 25th Oct. The barrel will close before the draws and will be emptied after the final draw each week.
9. Winners must be in the Club at the time of the draw and present themselves to the host in the Promotions area within 4 minutes of their name being called out and show their 2026 onwards Panthers Membership card. If they do not meet these requirements, then a redraw will commence.
10. If a unfinancial or lapsed member or invalid ticket is drawn, a redraw will take place until we have a valid winner.
